

Waiver of Liability

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES INVOLVED AT PANDORA'S LOCKS ESCAPE ROOM(S). I understand this activity is unsupervised and that there are certain inherent risks involved in the participation of Pandora's Locks escape room(s) along with their props/devices and I assume full responsibility for personal injury/death to myself and (if applicable) my family members, and further release and discharge Pandora's Locks, the directors, employees, representatives, landlords and agents for injury, loss, theft or damage arising out of my or my family's use of or presence upon the facilities of Pandora's Locks Escape rooms, whether caused by the fault of myself, my family, Pandora's Locks or other third parties.

I understand this activity has potential risks including but not limited to:

- 1) Crawling, crouching, bending;
- 2) Lifting, moving, pushing (no more than 50lbs);
- 3) Being in a reasonably small space with a max of 10 people;
- 4) Possibility in failing to escape the room in the allotted time;
- 5) Mental stress and anxiety;
- 6) Possibility of being exposed to (but not limited to) the following: lasers, fog smoke, black/dim lit rooms, strobing/flashing/pulsating lights, loud/sudden noises, vibrations, falling/suddenly moving objects;
- 7) Use of simple tools

I have no physical or mental illness that precludes my participation in a safe manner for myself or others. I am not under the influence of drugs or alcohol which may impair my ability to maintain my safety awareness or endangers others.

I agree staff have the right to remove me by any lawful means, without refund, from the game if I am:

- 1) Proving to be a danger to myself, staff, or other participants;
- 2) Showing signs of intoxication, drug or alcohol induced;
- 3) Not abiding by the list of rules agreed to before entering the room, such as: getting rough with and/or damaging property, not following verbal/written instruction by staff, using a recording/cellular device in the room. In the case of destruction of property, I agree to pay for all damages to the facilities caused by my or my family's negligent, reckless, or willful actions.

I agree that Pandora's Locks and its employees/representatives have the right to any photos or any video/sound footage of me during my time at Pandora's Locks facility. These photos, video footage, and sound materials may be used for any marketing purposes.

I agree to keep details of Pandora's Locks rooms confidential, as sharing this information could affect future customers' experiences as well as Pandora's Locks business.

I fully understand there are no refunds under any conditions once I purchase my entrance fee.
